JACKFIELD ENCAUSTIC TILE WORKS. (The Architect)

ENCAUSTIC TILES have been made in Jackfield for a number of years, but since the old works came into the possession of the present firm of Messrs. Craven, Dunnill & Co., great changes have taken place. The firm took a lease of about four acres of ground, and adjoining the old works built a large and commodious manufactory, which has been in operation for nearly two years. They have since taken down all the buildings of the old works and have erected on their site and joining up to their new works large new warehouses, showroom, offices, and entrance lodge. The plan of the works is very complete, so as in every way to economise in the process of manufacture, and they are now, probably, one of the most complete works of the kind.

The buildings consist of four blocks, one detached and the others connected, each block accommodating a separate branch of the manufacture.

In the detached block the raw materials are reduced to a state ready for the hands of the workmen. This building comprises the boiler-house, engine-house, pan-rooms, blunging-rooms, slip kilns and dust mills, together with stores for the various coloured clays as they leave the slip kilns ready for grinding.

The second block accommodates the work-people in the raw material, and the stores for the various clays and dust, as prepared for their use, and contains the damping places, where the clays are kept in a certain degree of moisture; pressers' shops for the various colours of geometric tiles, and the encaustic tile makers' shops, with their stoves.

The next block provides for the drying and firing of the goods and decorating shops, and comprises the "drying-house," where tiles made from dust are partially dried; the "seggar-house," where goods are prepared for and received out of the "ovens;" and the "ovens" where the goods are "fired" or baked, and also the glazing and enamelling kilns.

On the first floor are workshops employed for painting, enamelling, or other decorative purposes. The fourth block provides for the sorting and stocking of goods and for packing them for despatch; also the offices and showroom. It contains the sorting-house, best and second warehouses, showroom, offices for principals. and clerks, packing house, straw store, lodge, staircase, main entrance, lodgekeepers dwelling. &c. This part of the building is fitted with water-closets and lavatories, and there are separate earth-closets provided for male and female workpeople.

Near to the detached block first described a small gas-works has been erected, which supplies the whole of the buildings.

The encaustic makers' stoves, the drying-house, warehouses, and offices are heated by steam pipes from the engine-boiler.

There is a complete system of deep and surface-drains, and the yards and open spaces are well paved. Every part of the building has been carefully arranged, so as to meet the special purposes for which it is employed, and the connection of the several parts have been so adjusted as to economise labour to the utmost. Ample provision for the admission of light and air has been carefully studied, together with ease of supervision and management by the heads of departments.

All the workrooms are large, lofty, and well ventilated. The encaustic tile makers' room is 87 feet long by 25 feet wide, and the upper room of the warehouse block is 83 feet long by 36 feet wide, the roof being supported by massive, polished principals.

In the exterior design extravagance of detail has been avoided, as not appropriate to the purposes of the building; but, by a judicious use of local materials of good quality, and by a natural treatment of the many requirements of the promises, varying from perfect plainness in the mill and workshops to a freer handling in the warehouses, showroom, and principal entrance, a certain amount of architectural character has been attained which does not always accompany ordinary manufacturing buildings, but which, in this case, may be said rather to enhance the picturesque effects of the banks of the Severn, on which the premises are situated.

The general contractor was Mr. W. Exley, of Broseley, Mr. Bailey, of Ironbridge, sub-contracting under him for the joiners' work; Mr. Boulton, of Burslem, supplied the engineers' work, Mr. Price has acted as clerk of works, and Mr. Lynam, of Stoke-upon-Trent, was the architect.

The clays of Shropshire were turned to account by the Romans, and the relics dug up at Urconium, near the foot of the Wrekin, of tessellated tiles, made from red clay, were in all probability made from clays similar to those now worked at Jackfield. From a period so early as 1453 it would seem that the valley of the Severn was famous for ornamental tiles, for many specimens bearing that date have been found in cathedrals and churches. Jacquemart, in his "History of Ceramic Art," says that Jackfield is the most ancient site of pottery in Shropshire, and that there exists a specimen of its brown pottery dated 1634. It is also said that names of persons from Jackfield are entered in the parish registers of Stoke-upon-Trent who are supposed to have been potters as early as 1660, and the site of that old pottery was on the ground which is now occupied by the Jackfield Encaustic Tile Works. The clays of Jackfield are specially adapted for geometrical and encaustic tiles, and the red clay under the present works is probably the finest in the world.

Mr. James Craven was a native of Lincolnshire (*census states Colne, Lancashire*), but came to Manchester about 1850, and lived towards the end of his life in Upper Chorlton Road, and at Rixton Lodge, Seymour Grove.

He was an Alderman of the City of Manchester, and his interest in local affairs led to his being elected a member of the Stretford Local Board, as well as a member of the Local Board for the adjacent district of Moss Side. He was a builder by occupation, and soon after coming to Manchester was engaged on the erection of Holy Trinity Church, Stretford Road, Hulme. He died on August 20, 1887.

His eldest daughter Sarah married John Worthington, of the firm of William and John Worthington of Manchester, Contractors, both of whom resided in Seymour Grove, and his grandson, Frank Worthington, became a member of the firm of Crofton, Craven, and Worthington, Solicitors, Manchester. His second daughter, Mary Ann, married Taylor Sharpe, Esq., of Baumber Park, co. Lincoln. He had also three sons, John, Thomas, and Jonas; John died some years ago; Thomas was a partner, and is now a Director, of the firm of Gresham and Craven, Ltd., a Deputy Lieutenant for the county of Chester, and lives at Woodhays Park, Ashton-on-Mersey; he married Annie, daughter of William Halliday Cornforth, Esq., who was Churchwarden of Stretford 1860-1 862, and by her, he has issue three sons and a daughter.

Mr. Jonas Craven married Ada, daughter of David Chadwick, Esq., M.P. for Macclesfield, and died November 21, 1894, aged 42, leaving five sons and three daughters. He was educated at Shrewsbury Grammar School and was admitted as a Solicitor in 1875, after serving his articles with Messrs. Hulton and Lister. Until 1885 he was a partner with Mr. Brett, formerly Town Clerk of Salford, who was for several years partner with Mr. Frederick Blethyn Copley Hulton. In 1885 he joined Mr. H, T. Crofton, who had succeeded to the business of Hulton and Lister, which was thereafter carried on under the title of Crofton and Craven.

He was at one time a member of the Stretford Local Board and lived at Oak Lea, Upper Chorlton Road.

In memory of Alderman Craven the family erected the north porch of the Manchester Cathedral.

Frederick Charles Howells 1864-1933, manager

The Father

Thomas Howells was baptised on 27th April 1823 in Holdgate a small hamlet in Corvedale. In 1841 the family were living at Brookhampton to the east of Holdgate. His father Thoms Snr. had died and his mother Mary aged 50 is listed as a publican with Thomas (15) being employed as an agricultural

labourer. In 1843 he married Ann Evans, a native of Broseley in Shrewsbury and by 1851 he had trained as a cordwainer and moved to Broseley where his family were lodging with his father-in-law Thoams Evans a coalminer in Hockley Road. In April 1861 he was clearly doing well for himself as his is listed as a shoe manufacturer and was living on Barratts Hill. His wife Ann had died earlier in the year and his mother had moved in with the family. In 1863 married Mary Williams. Thomas continued to live on Barratts Hill until his death in1900, styling himself as a Master shoemaker in 1891. The house was rented and when it was sold in 1902 it was described as a Messuage or Dwelling House with yard and outbuildings. There was a cottage at the back of the dwelling on Padmans Alley both properties together were the subject to an amercement rent of 6s 8d to Lord Forester.

Thomas was said to have been a devoted member of the Congregational Church. He held the office of treasurer for several years, was a senior deacon up to the time of his death and had been superintendent of the Sunday School for 40 years.

Mary died in 1902 and is also buried in the family grave.

He may have been taken under the wing of Henry Powell Dunnill who was a prominent member of the Congregational Church. In 1881 he is listed as an Encaustic tile designer presumably working at Dunnill's and married Harriet Davies at Broseley in 1885. By 1891 they had moved to Ruabon, possibly working at the Dennis Works. He then moved to Clifton (Lancs) where he worked for Pilkington's returning to Broseley in 1912 to become manager of the Craven Dunnill works living at Field House on Queen Street. He died on 12th April 1933 and left £12,414 5s 2d (income value £4,980,000) with probate to his widow Harriet.

Harriett continued to live at Field House until she died in 1946. She left £16453 5s 7d (income value £3,074,000) with probate to Thomas Wilfred Howells company director (Craven Dunnill?)

Thomas Wilfred Howells 1887-1965

He was the only child of Frederick and Harriet.

He was born in Broseley in 1887 moving with his family to Ruabon and then to Clifton, Lancashire. In 1911 Thomas was living at Rooks Haven, Rake Leave, Clifton Junction, and was a Tile, Faience & mosaic designer presumably working at Pilkington's. He married Margaret Bowness, a Domestic Science Teacher (1888-1976) at Bolton in 1919 (Q2). Her father was a drysalter, oil refiner & paint merchant and had died in 1908. By 1921 he had returned to Broseley to take over the managership of the Craven Dunnill works and his family were living at Hurstlea next door to Alison House where his parents lived. He was living at the same house in 1939 and is listed as 'Managing director glazed & floor tile company'.

Thomas died in September 1965 at Hurstlea, Conduit Lane, Bridgnorth with probate to his wife Margaret. He left £10,487 (income value £568,700).
